**Object:** Advise according to Article 13 of the Law 196/03 "Normative in relation with respect of personal data treatment" (following "Normative").

Grand Italia srl (Socio Unico) company, via Palazzina 224, 37134 Verona, Italy, inform you, in accordance to Art. 13 of the Normative, that the personal data given from you to our company will be MANUALLY AND ELECTRONICALLY elaborated. The treatment operation of data are related to the purpose of complying with the law requirements. These data , therefore, are NECESSARY to give us the possibility of complying with the law requirements under and to which we are submitted. In the event that you will not provide them or that you will provide a wrong or incomplete information, we will not be able to fulfil the law requirements. The data will not be spread out while they could be transmitted to third parties , public or private, that operate in the environment for the above mentioned purposes and finalities.

More detailed, these data will be - or could be – transmitted to:

- persons, companies, enterprises, professional offices that provide services and/or activities of assistance and consulting in the administrative, financing, legal, tributes and software fields to the Owner;
- Public Enterprises that take care and operate only parts of the specified matter.

The full list of the names of these subjects is available at the Owner address.

Could be informed about your data parties responsible and/or committed by the Owner to the data treatment. Our company will overlook and take care that all the data treatment operations will be done according and with respect to the Normative. With reference to the data in our archive, will be always possible to claim the rights given by the Art. of the law in and under matter, herewith attached.

**ATTACHMENT – Art. 7 Law 196/2003-Normative with respect of personal data treatment**

1.The interested party has the right to obtain information about the existence of personal data that regard him, even if not yet registered, and the knowledge of these data in a clear readable layout.

2.The interested party has the right to obtain information regarding:

- a)the origin of the personal data;
- b)the purposes and criteria of treatment;
- c)the applied intelligence in the event of treatment done through electronic devices;
- d)the identification parameters of the Owner, the responsible persons and the representative named according to Art. 5 , chapter 2;
- e)parties or categories of parties to whom the data could be given or that could be informed as designed representatives in the Country Territory, responsible subjects or mandatory.

3.The interested party has the right to obtain:

- a)the update, correction and, when has interest to , the integration of data;
- b)the deletion, transformation into an unidentified layout or sudden block of the data elaborated against the law, including those for which is not necessary the archive according to the purposes for which the data has been previously collected and in a later phase elaborated;
- c)the demonstration that the operations with reference to letters a) and b) have been communicated, also with relation to what is concerning their subject, to whom the data have been forwarded and communicated , with exception when this fulfilment is impossible or requires the use of resources evidently out of proportion compared to the protected right.

4. The interested party has the right to oppose himself, totally or partially, to the treatment of data which refers to him:

- a)for legitimate reasons, also regarding the purpose of the collection;
- b)in order to send advertisement/direct sales/market research/commercial communications material.
